- You may ask for an appeal within 65 days of the date of our Notice of Denial of Medicare Prescription Drug Coverage.

Your prescriber can ask us for an appeal on your behalf. If you want another person (like a family member or friend) to file an appeal for you, that person must be your representative. Call us to learn how to name a representative.
